**COMPLAINT**

**NOW COMES** the Plaintiff, Angas William "Bill" Reid (hereinafter, "Bill Reid" or "Plaintiff"), by counsel, and respectfully moves this Court for judgment against Defendant Abby O'Connor, (hereinafter "Defendant") and alleges as follows:

**NATURE OF THE ACTION**

1. This action arises from a campaign of deliberate and malicious statements made by Defendant beginning on or about March 13, 2025.

2. What began as a single Facebook post – falsely alleging, *inter alia*, that Bill Reid was an instigator of domestic violence and had brandished a firearm at Defendant – quickly escalated into a broader campaign of fabrications, disseminated across multiple platforms and social and business circles. Among the most egregious falsehoods aimed at Bill Reid and his family was an allegation so grotesque and patently false that it defies belief: that Plaintiff's daughter and son were engaged in a long-term incestuous relationship. (See text messages attached as Exhibit "T"). Defendant herself characterized her objective in this campaign as creating the "biggest spectacle this town has ever seen," and her conduct reflects that goal – a calculated and sustained effort to humiliate,

intimidate, and permanently tarnish Bill Reid's name. (*See* text message attached as Exhibit "J"); (*see also*, text messages from Plaintiff to a family member of Bill Reid that he is "going down no matter what, the whole city knows it" attached as Exhibit "V").

3. Upon information and belief, Defendant's actions were undertaken with the intent to punish Bill Reid based on Defendant's belief that Plaintiff was responsible for the termination of Defendant's relationship with Plaintiff's son, Andrew. (*See*, text messages from Defendant to Bill Reid's son attached as Exhibit "W") [Defendant writing, "Call me when u get this so we can talk and set everything straight I'm not mad at you *I am pissed at your father and sister for doing this to us*"] (emphasis added).

4. Bill Reid originally chose to remain silent, hoping the storm of falsehoods would pass without further damage. However, as Defendant's campaign has proven relentless – and as the harm to his reputation, livelihood, and family has only deepened – he now finds himself with no real choice but to act. Bill Reid brings this action not just to recover the damages brought about by Defendant's conduct, but to stand up for the truth and to finally have the opportunity to defend himself in a forum where facts, not spectacle, prevail.

#### **PARTIES AND JURISDICTION AND VENUE**

5. The plaintiff, Bill Reid, is and at all times relevant herein, was a resident of the City of Virginia Beach, Virginia.

6. Bill Reid is a partner and manager of Elevation27 – an entertainment venue largely hosting musical acts.

7. The defendant, Abby O'Connor, is and at all times relevant herein, was a resident of City of Virginia Beach, Virginia.

## FACTUAL ALLEGATIONS

### *(a) Origins of the false and defamatory statements*

8. Prior to March 13, 2025, the parties were known to each other because Andrew Reid (hereinafter “Andrew”), Bill Reid’s son, was in a relationship with Defendant.

9. Likewise, during that time, Andrew lived with Bill Reid. Accordingly, Defendant frequently visited Plaintiff’s home and often stayed overnight with Andrew.

10. Prior to March 13, 2025, Bill Reid and other members of Andrew’s family observed the volatile and toxic nature of the Defendant. Consequently, Bill Reid and others sincerely urged an end to the relationship, fearing that Defendant was not stable.

11. Nevertheless, the relationship continued, and in February of 2025, the Defendant became embroiled in an argument over a trip that Andrew planned to take without her – a trip which Defendant had vehemently opposed.

12. After Andrew left for the airport to take that trip, Defendant, while in Bill Reid’s home, sent text messages to Andrew in which she stated, *inter alia*: “I will 100% be swallowing pills to die in my sleep... You tell anyone about this I’m putting a bullet through my brain... I’m crashing my car once I leave mark my fucking words, I hope I make the news...” Defendant then texted Andrew pictures of a gun to her head and a picture of Andrew’s belt hanging from his ceiling fan like a noose. (See text messages attached as Exhibit “A-I”).

13. Likewise, at that time, after her threats of self-harm, she subsequently threatened to harm Bill Reid’s daughter and her husband, demanding and telling Andrew, via text, to “Don’t text [Bill Reid’s daughter] either or I’ll kill them.” (See Exhibit “C”). Notably, both Bill Reid’s daughter and her husband were sleeping in Bill Reid’s house at the time those text messages were sent in a room close to Defendant. (See Exhibit “E”).

14. Shortly thereafter, while still en route to the airport, Andrew called Defendant's father out of concern for Defendant's behavior and to arrange for her to be picked up from Plaintiff's home. Once Defendant's father arrived, he apologized for Defendant's behavior to Bill Reid's daughter. (See Defendant's text messages attached as Exhibit "G").

15. As a result of Defendant's volatile behavior and threats, sometime after the aforementioned February 2025 event, Bill Reid prohibited her from entering his residence.

16. Despite being aware that Plaintiff had forbidden her from entering the property due to concerns over her prior erratic and threatening behavior, Defendant nevertheless returned to the residence on March 13, 2025. Shortly thereafter, Defendant created a scene (hereinafter "the Scene") at the residence.

17. Upon becoming awakened at 5:00 a.m. by the unhinged and intoxicated behavior of Defendant, Bill Reid directed Defendant to leave his residence. Defendant refused and called Virginia Beach Police – reporting that she was the victim of domestic assault by Andrew.

18. Notably, none of the events pertinent to this Complaint or the Scene occurred at Elevation27.

***(b) The false statements***

19. Defendant, in the hours, days, and months after the Scene, made numerous statements published on multiple social media platforms and websites and to social and business circles for the purpose of injuring Bill Reid personally, professionally and economically.

20. Defendant published and communicated these statements about Bill Reid knowing them not to be true.

21. On March 13, 2025, the morning of the Scene, Defendant published to her Facebook page, "I had a gun pointed at me by both Andrew and Bill Reid . . . . I want people to know Bill has

encouraged his son to beat me and has watched his son hit me and abuse me multiple times. (*See* Facebook post attached as Exhibit “K”). In the same post she warns people about supporting Elevation27 and tags the venues official Facebook page.

22. Thereafter, Defendant published to her Facebook page, “Elevation27 blocked me on Instagram and Facebook for speaking out about the abusive owner and manager, instead of taking accountability for being run by and employing DANGEROUS men who BEAT WOMEN!!!!.” (*See* Facebook post attached as Exhibit “L”). In the same post, she goes on to clarify exactly who she is referring to as the abusive owner, dangerous man, and woman-beater by writing that: “anyone who thinks Bill is innocent in this situation is so wrong because he was abusive not only to me but to his own son . . . . My dad and I are being threatened now by Bill’s family members because I spoke the truth about a horrific traumatizing situation at the hands of that man.” (*Id.*)

23. Likewise, Defendant published to her Facebook page that Bill Reid “TOLD his son to continue hurting me and all of this is going to come up in court cause my phone was recording everything . . . . Idgaf if he’s 70 years old you don’t allow much worse ENCOURAGE a man beating up a woman.” She goes on to warn people from associating with Bill Reid, his family, and Elevation27. (*See* Facebook post attached as Exhibit “M”).

24. Defendant published a photo to her Facebook page depicting the Defendant with facial injuries with the caption “Thank you Bill (and Andrew) Reid!!!! This isn’t even the half of it!!!!” (*See* Facebook posts attached collectively as Exhibit “N”).

25. Subsequently, Defendant published a Facebook comment on one of the above posts stating, “Bill dragged me by my ankle across the carpet and my nose ring got caught and he kept pulling me then told Andrew to ‘keep beating that bitch’ which is where the bruise in the photo came from,

my jaw on the other side of my mouth is broken and I have a concussion and my neck is fractured.” (See Facebook post attached as Exhibit “O”).

26. However, two days after the Scene, Defendant was arrested on charges of assault and battery, as well as brandishing a firearm, in connection with that event. Notably, upon information and belief, and in stark contrast to Defendant’s false and defamatory statements, Defendant’s booking photograph corresponding to those charges showed no visible signs of physical trauma to her face or neck. (See attached Exhibit. “X”).

27. Markedly, contrary to Defendant’s statements, (see e.g. Defendant’s post attached as Exhibit “AA” publishing, *inter alia*, that “[t]he owner and former general manager [of Elevation27] are awaiting a serious assault trial”), Bill Reid has not been arrested or charged with any offense involving the Defendant and/or the above-described Scene.

28. Thereafter, Defendant continued to publish similar statements on her Facebook and other social media accounts.

29. Subsequently, upon information and belief, Defendant’s Facebook account was banned or suspended for violations of Facebook’s terms of service related to her false and defamatory statements.

30. Upon information and belief, Defendant, utilizing an alias as a “Good Citizen,” caused to be published on Change.org similar allegations.<sup>1</sup> (See Change.org campaign page attached as Exhibit “P”). In that post, titled Close Elevation 27 — Stop the Abuse, the Defendant states: “I want people to know Bill has encouraged his son to beat me and has watched his son hit me and abuse me multiple times,” *inter alia*. (*Id.*).

31. Defendant left comments on that petition repeating many of the aforementioned statements and published new ones including that: Bill Reid was booted out of prior business relationships “under ‘mysterious’ circumstances;” Bill Reid told Andrew to “press false charges against me to make them look innocent;” and Bill and Andrew Reid both had “previous victims.” (*See* comments attached as Exhibit “Q”).

32. Moreover, while the petition, and Defendant’s broader campaign to defame Plaintiff, employs the rhetoric of contemporary social justice movements in an apparent attempt to lend credibility to, lend moral weight to, and increase the reach of her accusations, this language is a calculated facade. In truth, Defendant’s own communications reveal the use of hateful language, bigoted slurs, and viewpoints wholly inconsistent with the values she claims to espouse, thereby exposing the malicious and disingenuous nature of her statements. *Compare, e.g. (Id.) with, e.g., (Ex. F – I)* [Defendant plotting to make an employee of Elevation27 commit suicide by taunting her about the death of her “faggot friend” – an employee she also threatened to kill]; *and see* (Ex. T).

33. In addition, upon information and belief, Defendant posted or caused to be posted Reddit<sup>2</sup> threads and comments, utilizing aliases such as “SaltySuccess3168” and others, which restated the aforementioned false and defamatory allegations. (*See* comments and posts attached collectively as Exhibit “R”). Defendant has also published and continues to publish similar statements under other aliases on other mediums. (See Facebook posts attached as Exhibit “Y”) [showing Defendant, under the alias “Eloise Arden,” publishing those statements and urging the public to contact musical acts to pressure them not to perform at Plaintiff’s venue, thereby advocating for

further financial and reputational harm to Plaintiff]. (See also, additional false and defamatory statements made by Defendant under the alias of Eloise Arden attached as Exhibit “Z”).

34. More recently, Defendant has posted comments or posts on the website Nextdoor.<sup>3</sup> Those posts or comments repeated the aforementioned false and defamatory statements. (See comment attached as Exhibit “S”).

35. Bill Reid, both personally and through counsel on March 25, 2025, notified Defendant of his concern regarding Defendant’s false and defamatory statements. Additionally, third parties have also notified Defendant of their concerns regarding those statements. Despite these notifications, Defendant continues to publish the above-referenced and other false and defamatory statements about Bill Reid.

***(c) The Defendant’s statements are false***

36. The above-mentioned statements made about Bill Reid by Defendant are false.

37. Defendant knew that her accusations – that Plaintiff perpetrated, encouraged, or supported acts of violence against her – were false because she was personally present for the events she described and is aware that Plaintiff never engaged in any such conduct. Moreover, Defendant has never witnessed Plaintiff perpetrate or condone violence against her or against any other women. Consequently, Defendant had no factual basis for those statements – or acted with knowledge of their falsity, in reckless disregard for the truth, and/or in a negligent manner – in making those claims.

38. Likewise, Defendant similarly knew, for the same reasons, that Bill Reid did not ask Andrew to press false charges against Defendant or that he had any prior victims.

39. Moreover, Defendant had no factual basis for the statement – or acted with knowledge of its falsity, in reckless disregard for the truth, and/or in a negligent manner – in claiming that Plaintiff sent or caused death threats and other harassing messages to be sent to Defendant’s family and friends.

40. Defendant had no factual basis for the statement – or acted with knowledge of its falsity, in reckless disregard for the truth, and/or in a negligent manner – in claiming that Bill Reid had been arrested and/or charged with an offense involving the Defendant or the above-described Scene. As stated above, Bill Reid has never been arrested or charged with any crime involving the Defendant and/or the Scene.

41. The false and defamatory statements made by Defendant are factual assertions – not mere expressions of opinion.

***(d) Bill Reid’s reputation and financial interests suffer as a result of Defendant’s false and defamatory statements.***

42. As a result of Defendant’s false and defamatory statements, Bill Reid’s reputation and financial interests sustained substantial damage.

43. For example, as a direct result of Defendant’s conduct, entertainment acts that were set to perform at Elevation27 refused to perform or backed out of performing at the music venue leading to financial harm to Defendant. (*See e.g.* social media posts and comments from members of the public reiterating Defendant’s false statements attached as Exhibit “U”).

44. Moreover, Bill Reid’s business relationships have been substantially harmed because of his loss of reputation in his community, locally and nationally, and in his profession and trade.

#### **I. COUNT I | DEFAMATION *PER SE***

45. Bill Reid repeats and re-alleges each of the foregoing paragraphs as if set forth fully herein.

46. Upon information and belief, the aforementioned statements were communicated to third parties through various means, including oral conversations, phone calls, emails, online submissions, and social media posts and comments.

47. Those aforementioned statements were made with no factual basis, with knowledge of the statement's falsity, with reckless disregard for the truth, and/or in a negligent manner.

48. Likewise, Defendant made or published these false statements with the specific purpose to cause emotional, financial, and professional damages to Plaintiff.

49. Defendant's false and defamatory statements are clearly intended to articulate criminal conduct, acts of moral turpitude, that Plaintiff is unfit for employment as a partner and manager of Elevation<sup>27</sup>, and prejudice Plaintiff in his profession or trade – actions which are libelous *per se*.

50. Accordingly, Defendant's false statements make her liable to the Plaintiff pursuant to Va. Code § 8.01-45 and common law defamation *per se*.

## **II. COUNT II | DEFAMATION *PER QUOD***

51. Bill Reid repeats and re-alleges each of the foregoing paragraphs as if set forth fully herein.

52. Upon information and belief, the aforementioned statements were communicated to third parties through various means, including oral conversations, phone calls, emails, online submissions, and social media posts.

53. Those aforementioned statements were made with no factual basis, with knowledge of the statement's falsity, with reckless disregard for the truth, and/or in a negligent manner, and harm the reputation of Bill Reid as to lower him in the estimation of the community, to deter third persons from associating or dealing with him, and expose him to public hatred, ridicule, and contempt.

54. The harms to Bill Reid's reputation are evident in the vitriolic comments and posts made about Bill Reid which perpetuate the false and defamatory statements made about him by Defendant, by entertainment acts refusing to perform at Elevation27, and the virtual signatures made by members of the public on Defendant's Change.org campaign, *inter alia*.

55. Likewise, those statements were made with the specific purpose to cause emotional, financial, and professional damages to Plaintiff.


56. As a result of Defendant's actions, the false statements, and their continued publication, Bill Reid has suffered and continues to suffer immense emotional, financial, professional, reputational, business, and economic damages.

57. Bill Reid has and continues to have damages as a result of the physical manifestations of the above, past financial loss, and any reasonably anticipated future financial loss as a result of his loss of reputation.

58. Accordingly, Defendant's false statements make her liable to Plaintiff pursuant to Va. Code § 8.01-45 and common law defamation.

WHEREFORE, Defendants request judgment against Defendant for: (1) compensatory damages in the amount of \$2,000,000.00; (2) punitive damages in the amount of \$1,000,000.00; (3) together with pre-judgement interest at the legal rate on such amount awarded as allowed by law from March 13, 2025 until paid; (4) costs of suit; (5) preliminary and permanent injunctive relief restraining Defendant, including any efforts by Defendant to act in concert or coordination with others, from continuing the unlawful and tortious conduct described herein; and (6) such other and further relief as the court deems just and proper.

Not sure if anyone saw the social media posts about Elevation 27 but I am the victim who made the original post. Yes it is all true, and yes they pressed false counter charges against me. My Facebook and Instagram accounts were reported for defamation and suspended, but not before the Reid family made several fake accounts harassing me, my family, and my friends.

For those who don't know - Bill Reid is the founder and majority owner of the music venue Elevation27 in hilltop. He formerly owned the norva and the national in Richmond, which he both was booted out of under "mysterious" circumstances. His son, Andrew Reid, was my boyfriend up until I had to call the police on him two weeks ago for attacking me. Andrew was also the general manager and bar manager of the venue. I was grabbed by my hair so hard that my scalp was bleeding severely, I have a traumatic brain injury and concussion, and my jaw was fractured. I am still not fully recovered. I had a gun pulled on me by both Bill and Andrew.

Important to note: this did not happen AT the venue, but rather in the car of and at the private residence of the owner and manager. I tried to call 911 twice and it was not until the 3rd time hours later that I was finally able to get help because my phone was taken from me and I was struck unconscious. I have video and photographic evidence of all of this, however Bill told Andrew while he was in jail to press false charges against me to make them look more innocent. Additionally, the official business page made a post publicly bashing and blaming ME for being assaulted by these men at their home, when I didn't even want to be there in the first place.
